EMERGENCY PROCEDURES

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Do NOT touch or walk through spilled material. Keep bystanders away. Wear overalls, chemical resistant gloves, boots and safety goggles. Prevent further spillage. Sweep up solids without generating dust and place in a sealable container. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Dispose to a suitable landfill.
Fire	Call the fire service: Dial 111. This product is combustible. During a fire, combustion products are toxic and or irritant. When fighting a major fire wear an air supplied respirator. Wear protective equipment. Extinguish warehouse and factory fires using dry chemical extinguisher, foam, carbon dioxide or water spray. Do not use a direct jet of water. Cool sealed drums with water to prevent rupture from thermal expansion. Contain run-off.

FIRST AID

If Swallowed:	Do not induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.
If in Eyes	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Remove contact lenses if easy to do so. Call a Doctor or National Poisons Centre for advice.
If on Skin	If skin or hair contact occurs, remove contaminated clothing and immediately wash the affected area with soap and water. Do not scrub the skin. Call a Doctor or National Poisons Centre for advice.
If Inhaled	Remove patient to fresh air and rest. If not breathing, give artificial respiration, preferably mouth to nose. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.

STORAGE AND SEGREGATION SUMMARY

Storage: Keep out of the reach of children. Store in original container in a cool, dry, ventilated area away from direct heat or sunlight. Store away from foodstuffs, seeds, fertilisers and animals.. Avoid temperatures below 5°C and above 35°C.
