### EMERGENCY PROCEDURES

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or leak</b>	Keep bystanders away. Wear overalls, waterproof gloves, boots and safety glasses/ goggles. Prevent further spillage. Absorb spilled product and place in a sealable container. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Dispose to a suitable landfill.
<b>Fire</b>	<b>Call the fire service: Dial 111.</b> Wear PVC Protective clothing and breathing apparatus. Extinguish fires with water, fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture from thermal expansion. Contain run-off. Keep non-involved people away

### FIRST AID

<b>If Swallowed:</b>	Do not induce vomiting. <b>For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.</b>
<b>If in Eyes</b>	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Remove contact lenses if easy to do so. Call a Doctor or National Poisons Centre for advice.
<b>If on Skin</b>	If skin or hair contact occurs, remove contaminated clothing and immediately wash the affected area with soap and water. Do not scrub the skin. Call a Doctor or National Poisons Centre for advice.
<b>If Inhaled</b>	Remove patient to fresh air and rest. Maintain half upright position if breathing is difficult. <b>For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.</b>

### STORAGE AND SEGREGATION SUMMARY

**Storage:** Store in original container in a cool, dry, ventilated area away from direct heat or sunlight. Store away from foodstuffs, seeds, fertilisers and animals. Keep out of the reach of children. Keep container sealed when not in use.
